Description

1. The Department of Education- Schools Division Office of Angeles City, from the SARO No. OSEC 3-24-4784 dated July 1, 2024 intends to apply the sum of One Million Five Hundred Forty-Six Thousand Six Hundred Thirty-Seven Pesos and One Centavo Only (Php 1,546, 637.01) being the Approved Budget for the Contract (ABC) to payments under the contract for Lot 2 - Procurement of Supplies and Materials for Printing of Transition Learning Resources in Grade 7 and Grade 4 - Music and Arts Lesson Exemplars (LEs) and Worksheets (WSs) for School Year 2024-2025. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Department of Education - Schools Division Office of Angeles City, now invites bids for Lot 2 - Procurement of Supplies and Materials for Printing of Transition Learning Resources in Grade 7 and Grade 4 - Music and Arts Lesson Exemplars (LEs) and Worksheets (WSs) for School Year 2024-2025. Completion of the Project is required within 30 days after the issuance of Notice to Proceed. Bidders should have completed from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

(i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from Department of Education– Schools Division Office of Angeles City and inspect the Bidding Documents at the address given below from Monday to Friday, 8:00 a.m. to 5:00 p.m.

5. A complete set of Bidding Documents may be acquired by interested bidders Monday-Friday from October 2, 2024, to October 15, 2024, 8:00 a.m. - 5:00 p.m. and October 16, 2024, from 8:00 a.m. - 9:30 a.m. at Jesus Street, Pulungbulu, Angeles City, and upon payment of the non-refundable fee, pursuant to the latest Guidelines issued by the GPPB as stated below:

Approved Budget for the Contract Maximum Cost of Bidding Documents (in Philippine Peso) 500,000 and below 500.00 More than 500,000 up to 1 Million 1,000.00 More than 1 Million up to 5 Million 5,000.00 More than 5 Million up to 10 Million 10,000.00 More than 10 Million up to 50 Million 25,000.00

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

Interested bidders are required by the Division BAC to submit a letter of intent to participate in the bidding, and a Special Power of Attorney (SPA) if the buyer is a representative of the owner of the company. Bidders are also required to submit their Gmail address/account, upon buying of Bidding Documents, where the BAC Secretariat will send a link for the pre-bid opening.

6. The Department of Education, Schools Division Office of Angeles City will hold a Pre-Bid Conference on October 2, 2024, 10:00 a.m. at L&D Conference Room.

7. Bids must be duly received by the BAC Secretariat at the address below on or before October 16, 2024, 10:00 a.m. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

The opening of bids will be on October 16, 2024, 10:00 a.m. at L&D Conference Room. Bids will be opened in the presence of the bidders' representatives who choose to join in the bidding.

8. The Department of Education- Schools Division Office of Angeles City reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
